Maurice J Kirk BVSc – the Worst Case of Police Harassment and Political Imprisonment:

Maurice Kirk was not only a well loved veterinary surgeon in Somerset, Guernsey and South Wales, but also a world renowned pilot who won the [London Sydney race in 2001](#)¹ in an historic aeroplane.

However, South Wales Police got him struck off the Veterinary Register by such dishonest means that he kept trying to get redress. At the heart of the issue is the embarrassment of South Wales Police who mistook the replica of an historic weapon for a 'machine gun' and kept covering up their mistakes with excessive bullying and extreme harassment. In 2009, he was falsely imprisoned for 4 months and kept in a psychiatric clinic for another 3 months. This attempt to get him 'sectioned' for life, was, however, not the end of the abuse of psychiatric reports, a summary of which is [here](#)⁵.

A 'chronic litigant' and seasoned McKenzie Friend, he began helping [Bishop Gloria and Revd. Joseph Musa](#)⁶ In August 2011. Their six children had been taken by Haringey Council in April 2010 - without legal paperwork and South Wales Police' pattern, to cover up mistakes by crimes, was repeated.

In fact, Tottenham Police tried to section Maurice Kirk, using the falsified report of 2009 and he has been imprisoned since 22nd December 2011, without clear charges, his right for bail applications being refused, Draconian prison conditions and with question marks hanging over his trial for Civil Damages Claim, that by now will have been running for nearly 20 years.

He has been on hunger strike on several occasions. This time he writes: [I am an unconvicted Political Prisoner and will continue my hunger strike](#)⁷.
