And upon the Court reading (i) the Case Summary and Draft Order prepared on behalf of the Applicant (ii) Assessments dated 19 September 2011 in respect of the First and Second Respondents following their arrest on that date (iii) Logs from the Metropolitan Police Specialist Crime Directorate (iv) Internet material relating to these proceedings (v) excerpts from the webpage known as 'Kirk Flying Vet' (vi) the affidavit of Barnaby Dowell sworn 22 September 2011

And upon the Court being satisfied that it is appropriate to make an order *ex parte*

And upon the Applicant undertaking to swear an affidavit confirming the truth of the contents of the Case Summary dated 22 September 2011 prepared on its behalf by Malcolm Chisholm of counsel, and to exhibit thereto (i) the Case Summary and Draft Order prepared on behalf of the Applicant (ii) Assessments dated 19 September 2011 in respect of the First and Second Respondents following their arrest on that date (iii) Logs from the Metropolitan Police Specialist Crime Directorate (iv) excerpts from the webpage known as 'Kirk Flying Vet' (vi) the affidavit of Barnaby Dowell sworn 22 September 2011.

IT IS ORDERED THAT

1. That Gloria Musa, Chiwar Musa and Maurice Kirk are forbidden from removing or attempting to remove the children Favour Musa, Blessing Musa, Lerato Thabitha Musa, Abraham Musa, Sarah Musa or Queen Elizabeth Musa from their foster homes, from the care of their foster carers, or from any school that they attend.

2. That Gloria Musa, Chiwar Musa and Maurice Kirk are forbidden to instruct or encourage any other person from removing or attempting to remove the children Favour Musa, Blessing Musa, Lerato Thabitha Musa, Abraham Musa, Sarah Musa or Queen Elizabeth Musa from their foster homes, from the care of their foster carers, or from any school that they attend.
3. That Gloria Musa, Chiwar Musa and Maurice Kirk are forbidden to make enquiries as to the address of any building where any of the children Favour Musa, Blessing Musa, Lerato Thabitha Musa, Abraham Musa, Sarah Musa or Queen Elizabeth Musa live or attend school.
4. That Gloria Musa and Chiwar Musa are directed to use their best endeavours to ensure that all material or information (i) relating to any of the children subject to these proceedings, including any photographs of the children, and (ii) relating to the foster carers of the children (including all references to their address and all references to their family members), is removed from all public computer networks, all internet sites including <http://gloriamusa.wordpress.com/> (and all associated subpages) by 4pm on 29 September 2011.
5. That no person shall make available on the internet, whether on Facebook, Twitter, a blog, or any social networking site, or otherwise any part of (i) this Order, or (ii) the Case Summary and Draft Order prepared by Malcolm Chisholm on behalf of the London Borough of Haringey on 22 September 2011 (iii) the affidavit to be sworn by the Applicant referred to in the preamble to this order (iv) the affidavit of Barnaby Dowell sworn 22 September 2011.

6. That a penal notice shall be attached to paragraphs 1 to 5 of this order.
7. That this matter shall be listed for further consideration before the President of the Family Division on **Tuesday 4 October 2011 at 9.30am with a time estimate of two hours.**
8. Liberty to Gloria Musa, Chiwar Musa and Maurice Kirk to apply to vary or discharge paragraphs (1) to (6) of this order on giving **24 hours' written notice** to the Local Authority's solicitor Ms Dorothy Simon.
9. Leave to the Applicant to redact prior to service the names of the Supervising Officer and the Researcher appearing respectively on pages 1 and 2 of the Police Logs referred to above.
