I wish to make a complaint against South Wales Police in relation to an investigation against me in June 2009.

I have previously self-written a statement outlining my complaint, dated 20th August 2010, which would state the way in which the account of my complaint.

My complaint was initially subject of dispensation application, which appealed to the IPCC in relation to that matter and the IPCC dismissed many of the points. The IPCC did, however, uphold two areas, namely:-

with a decommissioned Lewis Machine Gun in order to make it capable of firing.

2) Discrepancies in evidence obtained relating to the Lewis gun and false evidence concerning an undercover operation.

In relation to point one, I make this allegation on the basis of evidence given at court by Gerry COOPER, who is an ex RAT informer. He was the gentleman who I sold the gun to in the first instance, at which time the barrel was blocked.

Under cross examination he gave evidence that the police had showed him the gun, a month or two after I was arrested and at that time the barrel was unblocked. I am alleging that the police deliberately unblocked the gun.

I would also like to add that when I sold the gun to Mr. COOPER, the magazine was black but when Mr. COOPER handed over the gun to the police, the magazine was grey because he had painted it. He said this.

when I went to see him in August 2011, at an airfield in Lincolnshire. In fact, there is also a video of me holding the gun which was used by the prosecution, in which the magazine was black.

When the case was heard at Cardiff Crown Court on 25th January 2010, the police presented the Leiris gun on which occasion the magazine was black again. I am convinced that the police painted the magazine black in order to make it match the video.

I was charged with offences in relation to the Leiris Machine gun and I was acquitted. I am subsequently told by Mr. Cooper that when the gun was returned to him the magazine was back to a similar colour that he had painted it.

The other area I wish to complain about is tactics used by the police and false evidence given in court.

arrest, the police were ringing my home, claiming to be somebody else, in an attempt to purchase a gun. I can't remember how many calls there were but both my wife and I spoke over the phone.

I spoke to a female only but I can't be sure who my wife spoke to. My wife's evidence was given at court by the person who had allegedly made the phone calls. I am sure it was a male person who gave evidence, although this was behind a screen so I never actually saw him. In court, he used a pseudonym of 'Forx'.

In summary, I am alleging that the person who gave evidence is not the person who made the phone calls.

The calls were made to my home at the time, Marlborough in Saint Donats.

I would like to add that in mid August 2011, I went to see Mr. COOPER in Lincolnshire where I again saw the Harris Gen and

I can confirm that the magazine was grey in color. I would like to add that when he received phone calls, a few days prior to my arrest, I have established now that I was MAPPA level 3 registered, following a meeting of 8th June. One of the agencies at the MAPPA meeting has now provided me with the minutes which recode that should I approach the Chief Constable, I was likely to be shot. Following my successful court application an executive summary was made on 28th August 2010, which directed that I should apply to each agency if I wanted a copy of the meeting minutes. I have received letters dated 15.12.09 from Nigel PEEs, MAPPA co-ordinator, in response to a letter I sent. This letter basically informed me that I was MAPPA level 3 and I would be informed of any change in my status.

A further letter from Nigel PEEs, dated 31.12 states that I received an executive summary

but that disclosure of further material will only be done by a Court order.

These letters form part of my complaint for lack of disclosure to me.

I have established that the MAPPA meeting of 8th June took place at Barry Police Station, without other agencies being present, other than Dr. Regyn Williams's agent.

I was never told I was so registered and why I was removed from the Register on 17th December 2009. I have further evidence to support the fact that this was a conspiracy between Barbara WILSON and Dr. Regyn WILLIAMS, following his 25th February 2007 false sworn affidavit, relating to my 20 year litigation for damages against the South Wales Police.
