## WITNESS STATEMENT

## Cardiff Crown Court - Maurice John Kirk V South Wales Police

- I, Dafydd Emyr Morgan of 15 Clos Pencarreg, Aberaeron SA46 0DX, make this statement in support of Maurice Kirk and to assist the Court with important additional background:
- I have known Maurice Kirk for over 10 years and found him to be a gentleman, trustworthy, of sound mind and entirely dependable. He may be a little eccentric but poses no threat to anyone.
- 2. I have been in business for thirty odd years and became a financial activist in 1998 when I found that our family estate comprising three of the most productive local farms and the family retail business in the middle of Aberystwyth had come under threat from a gang of nobodies, who were eager to steal the land and properties so that they could launder dirty money from for example, cocaine.
- 3. Both the Maurice Kirk and my case have more or less run in parallel with one another and we together with a number of others have been subjected to a determined, ruthless and relentless hate campaign to destroy us, damage and publicly tarnish our reputations through a widespread gossip and media campaign.
- 4. When I attended a pre-trial review of this case in Cardiff Crown Court on 23<sup>rd</sup> July 2017, I handed the CPS team a copy of my report to Thames Valley Police which I have attached Exhibit DEM01.
- 5. I met Maurice Kirk at our Stand Your Ground meetings in Carmarthen, one of which was attended by then Adam Price MP, now Assembly Member for Dinefwr, Carmarthenshire who chose to ignore what hundreds of people who attended the meeting told him.
- 6. I have been in periodic contact with Maurice Kirk ever since 2016 and give him my full support in his ongoing campaign for compensation against South Wales Police for years of bullying, the collapse of his business, anguish, stress and the needless breakdown of his family life, which I have suffered also.
- 7. The above is a deliberate plot to cause individuals the utmost harm as shown in the video link below where the public at large perceive a picture of victims who have 'lost the plot' Exhibit DEM02.
- 8. From my years of experience, the people victimised in this way have all been desperately trying to keep hold of their businesses, land and property. Each has been complaining and been repeatedly abused by the public sector who have been at pains to try and destroy us and avoid insurance claims. It may be important to investigate who benefits from the institutions not being insured, as the people responsible appear to be unwilling to accept the embarrassment of having to claim from the Crown.
- 9. These criminal plots are very similar to what we now know as RBS GRG and HBoS Reading where, instead of protecting customers; accounts, as per the banks terms and conditions, banks not just RBS and HBoS, have been collectively involved in conspiracies with organised criminal gangs in defrauding unsuspecting customers at will. How can you expect manual people within the agricultural sector to even suspect that they are being targeted by organised criminals?

- 10. It has taken me eighteen years to harness and master Dyfed Powys police, which I have done since it was found that the Director of Legal Services and Compliance, Samantha Gainard was being served by senior police officers.
- 11. Since that time, my issues have been reinvestigated by Assistant Chief Constable Pam Kelly (now Deputy Chief Constable of Gwent police) and we still have this argument over whether the issues are civil or criminal.
- 12. I have always maintained that the issues are criminal and that whilst they seem civil, in effect, the criminal gangs are reaching over the fence, in order to steal the apples (land and property).
- 13. When I spoke to Pam Kelly at the tail end of last week, she did tell me that she would, at some time in the future, be prepared to come to Court and give evidence in my favour and be able to explain in greater detail what the police now deem they are up against.
- 14. I therefore believe that Pam Kelly's assistance in this case is imperative. I have copied her into this correspondence so that she will be aware of Maurice Kirk's request for her to assist me and the court in these matters.
- 15. Pam Kelly also told me that my case has now been designated by both the Chief Constable Mark Collins and Assistant Chief Constable Darren Davies to Robyn Mason, Commander of Ceredigion division for him to organise a meeting with NatWest who are at the core of my own problems so that my home and smallholding, Gelli Angharad can be returned to me forthwith.
- 16. I have also copied in David Morgan, Regional Director NatWest, Cardiff and Andrew Woodthorpe, Director for Business Banking who are aware of my issues so that they can come and explain to the Court as to how banks have failed to protect customers' interests and become involved in widespread fraud against their own customers. The Court need to issue witness summonses against these two officers so that the Court will have a better understanding of the unfortunate and needless pressures that Maurice Kirk has been put under, through no fault of his own.
- 17. As farmers, we are all proud of the hard work, the blood, sweat and tears of our predecessors in paying for property and estates that they have passed on to this generation and will do whatever needs to be done to protect these assets.
- 18. As a farmer, I am no different and having been on this road, protecting our family farms and business intact, now for nearly twenty years, I completely resonate with the frustrations that Maurice Kirk has had to put up with and I offer no apology whatsoever to any of the organisations and corporations that have decided to stand in my way in protecting family assets and my own small holding.
- 19. Those who are still silly in wanting to stand in my way do so at their own (reputational) risk and are forewarned. My own campaign will not desist until I am sure that our family estates are safe and that my own home, Gelli Angharad has been returned and the damage that has been caused rectified.
