

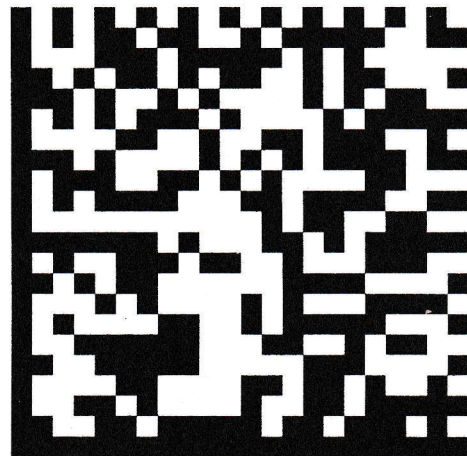

TRUTH SURROUNDING THE JUNE 2009 HELICOPTER CRASH WITH 20000 POLICE, MAN
ARMED, TO SWATCH OUT THEN 10 YEARS OLD GENEVIEVE, IN OPERATION 'CHALLENGER' TUKIP

JUDGEMENT AND TAKE ON MR KIRK'S ANAESTHETIC CARE.
