NINE PRISON TERMS TO BE OVERTURNED

1. I LANDED MY VINTAGE AIRCRAFT, APPARENTLY, TOO CLOSE TO EX PRESIDENT BUSH'S RANCH ONLY TO BE INDOMINIOUSLY CHASED IN WACOP PRISON AND ^{LATER} REPORTED IN 'THANKS'! FORTUNATELY, AT LEAST, I HAD OVERTURNED A SOUTH WALES POLICE RECOMMENDATION I BE FURTHER SECTIONED, LONG TERM, IN AUSTIN'S SECURE PSYCHIATRIC HOSPITAL. THIS WAS DURING 2ND DECOY HM PROSECUTION'S APPLICATION, ON BEHALF OF THE POLICE, I BE GRABED, INDEFINATELY, IN A SHAWORTH HILL SECURITY HOSPITAL.
